The Chamber in Ukraine

The American Chamber of Commerce in Ukraine ("Chamber") is among the most active, respected and effective non-government nonprofit business organizations operating in Ukraine since independence. One of the principle activities of the Chamber is to represent the internationally oriented investment community as well as to facilitate the entrance of potential new investors into this market. The Chamber advocates on behalf of their Members not only to the Ukrainian government but also to all other governments who are economic partners of Ukraine on matters of trade, commerce and economic reform.

The Member organizations of the Chamber represent many of the largest companies from more than 50 countries operating in Ukraine with a majority of the foreign direct investment. The diverse Membership base unites companies from a variety of regions and countries, including North America, Europe, Asia, Russia and Ukraine. Members collectively employ hundreds of thousands of Ukrainians providing them with exposure to international business practices and an opportu-

nity to develop into leading Ukrainian professionals, bring international expertise and business knowledge to Ukraine and are among some of the largest tax-payers in Ukraine and strive to be good corporate citizens.

The Chamber is an active and engaged member of the Foreign Investment Advisory Council under President Yushchenko, the Entrepreneurs' Council of the Cabinet of Ministers as well as a wide variety of Public Councils within the Ukrainian Ministries and State Committees.

Chamber Membership benefits include but are not limited to: effective and proactive Advocacy and Lobbying Activities; access and involvement in Chamber Committees and Working Groups; value added contacts and stratified business Networking; informative publications; wide variety of socially oriented and family focused events and activities; streamlined Express Business Visa Services; a money saving Member 2 Member Discount Program; continuously expanding Gourmet Club, etc.

2006 MEMBERSHIP SATISFACTION SURVEY

In order to obtain a better understanding of the level of satisfaction of the Membership with the Chamber's activities and priorities the Chamber in cooperation with Chamber Member Hudson Global Resources and with the support of Chamber Member MacHouse implemented a 2006 Membership Satisfaction Survey.

The Survey's primary objective was to provide relevant information that would assist the Chamber serve the Membership more effectively. The information obtained from the Survey was then utilized by the Board of Directors and Administrative Team during the strategic planning process whereby the Mission, Vision and Principles where adjusted to ensure the Chamber's strategic direction matches the needs and expectations of the Membership in this rapidly changing environment.

The Chamber was pleased that well over 1200 Members responded to the survey providing a statistically relevant sample size enabling the Chamber's Board of Directors Strategic Planning Committee to receive a clear snapshot of the perception of the Chamber among the Membership.

Overall, the Chamber performed well in the eyes of the Membership with some brief snapshots including:


• The Chamber is perceived as an organization effectively providing companies business networking opportunities, supporting their business activities through the provision of information and protecting their interests through lobbying and advocacy

- 92% of Chamber Members are happy with the Chamber services and believe their expectations from Membership are mostly met
- 99% of Chamber Members would recommend the Chamber as a reliable business partner
- 74% of Members think that the Chamber manages to contribute to business reforms in Ukraine and the majority of Member companies (80%) believe the Chamber manages to fully represent the Member's interests
- Committees which are the most active and effective include: Agricultural, Banking and Financial Services, Human Resources, IT Committee, Legal and Telecom. 40% of people attend regularly and 45% from time to time depending on the issues discussed during the Committee Meetings.
- Members indicated that the Membership Directory, Business Networking Events, Chamber Electronic Publications, and Discount Program are very important and highly rated products and services of the Chamber.

Among areas that have been identified for further development and strengthening in 2007 include: improving the variety of focus of different communication channels; strengthening of Advocacy and Lobbying activities utilizing different mechanisms and tools; and focusing more attention to issues of small and medium sized companies.




Satisfaction with Responsiveness to Member's Needs

During 2006 the Chamber's Policy Team in conjunction with the Board of Directors, Committee Leaders and active Members within the Chamber Committees and Working Groups were actively engaged in lobbying and advocating issues that are of importance to Members and keys for their success.

The Chamber's close working relationships with the Cabinet of Ministers, Parliament, Presidential Secretariat, State Committees and Public Councils have proven to be beneficial in moving the policy agenda of the Chamber forward by providing access to relevant decision makers, information and early warnings on draft legislation prepared by different State authorities, proactive involvement into the activities of a wide variety of Working Groups as well as participation in important meetings and round tables on priority issues for the private sector and investment environment.

In 2006, due to the new constitutional environment in Ukraine, the Chamber implemented new methods in regards to the realization of advocacy and lobbying activities. These included strengthening relationships with the Verkhovna Rada as well as introducing a new set of Chamber Policy Priorities, which were developed by the Chamber's Board of Directors Policy Committee. These Policy Priorities received a special focus from the Chamber Policy Team and all of the Chamber's Policy related activities were benchmarked against accomplishing these important goals.

- Tax Reform: VAT Administration; One Social Unified Tax; Automating of the Tax Reporting System, etc.
- WTO Membership: Draft Laws in the Parliament requiring support; IPR; Customs Duties; Standardization and Certification Policy, etc.
- Financial Sector Reform: JSC Law; Stock Market Development: Insurance Market; Leasing Legislation; International Standards in Financial Bookkeeping, etc.
- Liberalization of the Investment Environment: Registration and Permissions; Land Plot Allocation and Real Estate Market; Land Market -Land Code; Intellectual Property Rights; Customs Procedures, etc.
- Hi-Tech Industry Development: Techno-park and other incentives; Innovation Policy; Stimulation and Reforms in Education, etc.

In 2006 the Chamber worked closely with the Foreign Investment Advisory Council under the President of Ukraine and Entrepreneur's Council under the Prime Minister of Ukraine. These influential institutions met on a regular basis to address issues and provide analysis of draft legislation in economic, humanitarian and social policy. This year a special emphasis has been made in regards to unified social taxation issues and reforming the taxation system, legislation regarding State control and supervision of economic activities, as well as implementation of the Law of Ukraine "On the Permit System for Economic Activity".

Parliamentary elections and implementation of new Constitutional amendments both took place in the beginning of 2006 bringing with it political uncertainty. Due to the rapidly changing political landscape the Chamber was pleased to organize the "Parliamentary Elections In-Focus Series" that provided an excellent opportunity for Members interested in Ukrainian politics to meet with and hear directly from key political figures who were leaders in their respective political parties and blocs before, during and after the 2006 Parliamentary election campaign.

To analyze the election campaign process, results and nuances the Chamber also hosted leading political analysts Mr. Ilko Kucheriv, Ms. Iryna Bekeshkina and Mr. Mark Rachkevych from the Democratic Initiatives Foundation and Mr. Volodymyr Paniotto from the Kyiv International Institute of Sociology.

The Chamber Policy Team constantly explores ways to further improve cooperation between Member companies and the Policy Team regarding advocacy and lobbying initiatives of the Chamber and changes to legislation and regulations proposed by the Government and Parliament. In 2006 the Chamber launched a new project entitled "Policy Flashes" to inform interested Members properly and in timely manner on relevant issues that may impact their business.

The Chamber also continued to maintain an active and effective dialog with Governmental authorities through the network of Public Councils operating under the auspices of Ministries and State Committees and variety of Working Groups established under the umbrella of these institutions. The Chamber has been involved in the work of the Public Councils under the Ministry of Finance, Ministry of Foreign Affairs, Ministry of Healthcare, Ministry of Education and Science, Department on Intellectual Property Rights, Ministry of Industrial Policy, State Committee for Technical Regulation and Consumer Policy, State Committee for Regulatory Policy and Entrepreneurships, State Administration, State Customs Service and the State Property Fund.

The Chamber also cooperated with different important institutions of both legislative and executive power operating on central and local levels including but not limited to: Verkkhovna Rada Committees on Economic Policy, Banking and Finance, Agricultural Policy, Budget as well as the Council of National Defense and Security of Ukraine, National Department of Communication and Informatisation, State Committee on Stock Market and Securities and Kyiv State City Administration.

The establishment and operation of the Ukrainian Center on Attraction of Foreign Investments under the Ministry of Economy has also been a focus of the Chamber's activity in 2006 as a founding Board member and active supporter working to strengthen the Center's ability to provide relevant and timely assistance to new investors into the market.

Chamber Members were provided with a wide variety of opportunities to engage in a positive dialog with key decision makers within the Ukrainian Government through the Chamber Committees, Working Groups, General Membership Meetings, 'In-Focus' Meetings and Business Luncheons.



The Chamber's primary mechanism of developing and implementing advocacy and lobbying related initiatives are through the active Chamber Committees and Working Groups. Working Groups focus on specific legislation / regulations that can impact the Membership and bring together Members who are experts on those issues to develop recommendations and execute action plans to resolve various problems. Members of the Working Groups are involved in amending legislation and regulations through effective cooperation with governmental decision makers. The following ad-hoc Working Groups and Sub-Committees operated under the Chamber's umbrella in 2006:

An effective and successful example of a specialized Working Group is dedicated to combating Illegal Corporate Raiders. The Working Group gathered many leading lawyers from prominent law offices in Ukraine and as a result the White Paper



During 2006 the Chamber continues to maintain close contacts with variety of Ukrainian non-government organizations and business associations, such as Association of Franchising, European Business Association, League of Insurance Companies of Ukraine, National Association of Trade and Services, Ukrainian Grain Association, Ukrtytyun, Union of Small and Medium Enterprises and many others.









United States Government Relations

The American Chamber of Commerce in Ukraine has enjoyed a long and successful history of close cooperation with the United States Embassy in Ukraine as well as various U.S. government agencies and lawmakers in Washington D.C. This close working relationship has benefited our Membership over the years by providing access to information and input into a wide variety of policy decisions in regards to Ukraine. The Board of Directors regularly meets with delegations of U.S. law and policy makers to provide relevant input into the current business environment.

In the middle of 2006 Ambassador William Taylor assumed the role of U.S. Ambassador to Ukraine and in July the Chamber held a General Membership Meeting inviting Ambassador Taylor to share his thoughts and plans with Member companies.

Many significant positive movements in the Ukraine-US relationships happened in 2006 and the Chamber played an active role serving as a reliable partner and long-term supporter of Ukraine's Government. In the very beginning of 2006 U.S. Trade Representative Rob Portman announced that the United States has reinstated Generalized System of Preferences (GSP) benefits for Ukraine. Ukraine lost these benefits in 2001 after Washington found the country guilty of failing to protect intellectual-

property rights, and since that time the Chamber through its IPR and IT Committees advocated on implementation of appropriate mechanisms to protect the intellectual property rights for all industry players.

The Chamber was pleased to host Dr. David A. Sampson, the Deputy Secretary of the U.S. Commerce Department in February during his official visit to Ukraine. Deputy Secretary Sampson was the most senior Commerce Department official to visit independent Ukraine. He announced the granting of Market Economy Status for Ukraine from the United States during the Chamber meeting with Members and the press.

The Chamber was pleased to participate Jackson-Vanik Graduation Coalition that was co-chaired by former U.S. Ambassadors to Ukraine, Steven Pifer and William Miller, and included over 250 organizations and businesses that actively encouraged the U.S. Congress to pass legislation to graduate Ukraine from the Jackson-Vanik Amendment. On March 8 the House of Representatives of the US Congress adopted a bill graduating Ukraine from the Jackson-Vanik Amendment. The legislation granted Ukraine normal trade relations status with the United States. In September the Chamber hosted Mr. Frank Mermoud, Special Representative for Commercial and Business Affairs at the U.S. Department of State during his visit to Ukraine when he met with senior Ukrainian State officials addressing important issues and problems faced by the investment community in Ukraine.

The Chamber also served as an information partner of a wide variety of value added investment forums, exhibitions and conferences held in the U.S. as well as those which were held in Ukraine with the goal of attracting investment into the Ukrainian market including but not limited to: C3 Conference in New York, "Silicon Valley Open Doors" in Mountain View, California, Google meeting in Kyiv, Adam Smith Capital Markets meeting in Kyiv, etc.

On December 15th and 16th the Chamber was pleased to support the National Exhibition Conference of Ukraine in Chicago. This high-level event was organized by the Ministry of Economy of Ukraine and Chamber president, Jorge Zukoski, was a moderator of the panel entitled "Doing business in Ukraine - investors and business professionals discuss current trends, opportunities as well as challenges in this rapidly growing and dynamic economy". The two-day conference and trade fair highlighted business and investment opportunities in Ukraine as well as included round tables and seminars where industry specific topics were discussed by professionals and investors.

European Union Relations

The Chamber is an active Member of the European Council of American Chambers of Commerce ("ECACC"), which unites Chambers from all of the European Union and recent accession countries. In 2006 the Chamber President served on the Executive Committee of the Board of Directors of ECACC and worked closely with Chamber colleagues in Brussels at the European Commission to protect and serve our Members interests within the expanding European Union. This active

relationship allows the Chamber to address Member's business interests at the European Commission in Brussels as well as provide timely and relevant input regarding Ukraine as she strives towards further Euro-Atlantic integration and World Trade Organization accession.

In 2006 cooperation between the European Union and Ukraine was based on the European Neighbourhood Plan and "Road Map" Ukraine-EU adopted by the

Cabinet of Ministers in 2005. The Chamber played an active role in preparation of this important document. In October 2006 the 10th EU-Ukraine Summit took place in Helsinki where the new Enhanced Agreement was discussed and both parties agreed on a joint comprehensive and ambitious approach to be started from official negotiations in early 2007 and the Chamber looks forward to once again providing relevant input on behalf of our multinational Membership.







International, Diplomatic and Donor Community Relations

The Chamber continues developing cooperative relationships with many of the Embassies in Ukraine to assist the Membership with the resolution of critical issues impacting their businesses and strengthening of policy initiatives. In 2006 Chamber continued to meet Ambassadors and senior officials from many Embassies briefing them on the most important issues facing by the international business community. Also, the Chamber continues to facilitate the process of issuance of legitimate Business Visas for Members company employees. The United Kingdom and the United States Express Business Visa Service are based on formal arrangements and have proven to be both highly effective and valuable services for Chamber Members as well as for the Consular Sections of both Embassies. We also work informally with many Embassies to assist our Members to secure Business Visas for their key employees.

The Chamber continued to serve as information partner of many major strategic investment forums, conferences and seminars aiming to improve image of Ukraine and promoting investment opportunities and addressing key issues in the sphere of economic development and trade. To name only few of them: Ukrainian Banking Forum of the Adam Smith Conferences, Ukrainian Outsourcing Forum of the Ukrainian Hi-Tech Initiative, "PR-Days in Ukraine" by the International Public Relations Association (IPRA), Insurance Elite International Investment Congress of the Insurance Business, the "Made in Ukraine" series designed to highlight trade and investment opportunities in Ukraine organized in conjunction with USAID | BIZPRO and many others.

The Chamber continued to maintain contacts and hold meetings with leaders of the international financial institutions including European Bank for Reconstruction and Development, World Bank, International Monetary Fund, international rating agencies, etc. The Chamber is an active member of the International Trade Club. This non-profit organization is based in Kyiv and is organized with the assistance of the Ministry of Economy of Ukraine. The Trade Club consists of representatives of more than 60 countries. This year the Chamber together with many of our affiliated Embassies visited Kharkiv, Khmelnitsky, Poltava and Zhytomyr regions.

During these trips the Chamber always uses these opportunities to meet and establish relationships with key State Regional officials, who present their regions and inform the delegation on investment opportunities. We also meet with representatives of different enterprises that have already established good relations with foreign partners and with those who are looking for attracting additional foreign investments. All materials and information is available at the Chamber administrative offices.

COMMITTES

The American Chamber of Commerce's Committees and Working Groups are the core of the Chamber's advocacy and lobbying activities. Through the Committees the Chamber represents and actively lobbies Member's interest as investors in Ukraine.

In 2006 the Chamber had fifteen standing Committees as well as the Overseas Security Advisory Council and a changing number of Working Groups that focused on specific issues and industry sectors.

The Committee structure enables the Chamber to engage interested Members, over an extended period of time, in industry and sector specific policy related issues. The Committees are standing and many of which have been active for many years. On the other hand, the Chamber Membership utilizes Working Groups to focus on specific issues and bring together Members who are experts on that issue to develop and execute an action plan to resolve the problem and then disband. This structure is very effective in resolving specific issues in a short period of time. The Chamber will continue to strive to establish value added Committees and Working Groups as identified by the Membership.









AGRICULTURAL COMMITTEE

The Chamber's Agricultural Committee Mission is to support and promote the development of a market-based agricultural sector as a significant contributor to the overall development of Ukraine's economy. The Agriculture Committee is a forum to proactively address issues within the Ukrainian agricultural industry and is open to all interested Members of the Chamber. The Committee's main goal includes developing the Ukrainian agricultural sector through positive interaction with relevant policy-makers and other stakeholders.

In 2006 the Committee held regular meetings on monthly basis and continued to serve as an excellent platform for topical information sharing, updates on harvest prospects/results, grain export, VAT reimbursement and legislative and taxation issues.

Examples of major issues that the Agriculture Committee was actively involved in included but is not limited to:

VAT reimbursement -

VAT reimbursement is an ongoing long-term issue that the Chamber's Agricultural Committee and Tax Committee has been actively engaged within that was rather successfully resolved in the recent past.

Unfortunately, in the middle of 2006 problems with VAT refunds again

emerged on a large scale and the Agricultural Committee addressed Mr. Mykola Azarov, First Vice-Prime Minister to work towards a resolution of this contentious and ongoing issue. The Chamber was told that the Government had not permanently stopped VAT reimbursement but was in the process of conducting audit procedures due to a claim that a large number of violations in the sphere had taken place earlier in 2006 as well as in 2005. Despite the government imposed discontinuation of VAT refunds during the audit procedures, some reimbursements were being executed in a non transparent or equitable manner leading the Chamber community to continue to advocate for the improvement of the VAT reimbursement procedure. The Chamber will continue to address all relevant decision makers including the Cabinet of Ministers, Presidential Secretariat, State Tax Administration and the Council of National Security and Defense on the matter.

• Grain Export Licensing - Grain Export Licensing was introduced by the government at the beginning of fall 2006. The Chamber approached Vice Prime Minister Klyuyev addressing the problem of introducing grain export licensing in the middle of the year when export contracts have been already signed. After addressing the problem to Mr. Klyuyev, the Chamber continued to communicate with key decisions makers such as the Minister of Economy, representatives of the Ministry of Agriculture and the State Customs Service of Ukraine. Also,

Members discussed this issue in regards to the possible negative impact of the imposition of a licensing regime in Ukraine's WTO accession plans.

- Bird flu another major issue that was of concern to the Agricultural Committee at the beginning of the year was bird flu that could have become a major problem during the migratory season. The Agriculture Committee kept their Members informed as to the latest steps being taken to combat this disease and will remain on their radar screen in the future.
- Elevator storage price not higher than 5% of "minimum purchase price" Members understood that the Law that introduced this regulation was on the books for a while but was never enforced until 2006. The Agricultural Committee maintains position that the prices should be the subject of a
- enforced until 2006. The Agricultural Committee maintains position that the prices should be the subject of a market decision instead of State position supported by the law. It was decided to clarify some of the small problems inside this issue and to be ready to address it to the government.

Cooperation with Verkhovna

Rada Committee on Agrarian Policy and Land Relationship - Members were updated on draft legislation that was registered in the Verkhovna Rada Committee on Agrarian Policy and Land Relationship and discussed possible questions to address to Mr. Gladiy, Head of the Committee.

The Banking Committee has identified its Mission to be an active participant in Ukrainian banking system development and promotion of high quality banking standards and values. The Committee supports and develops initiatives of the Ukrainian government and local banking associations towards establishment of local banking environment harmonized with the best international banking practices.

At the beginning of the year Banking Committee held a **Strategy Planning Meeting** were Members of the Committee agreed to issues that Committee should focus on during 2006 and decided to join the Banking Committee and Finance and Investment Committee into one Banking and Financial Services Committee.

In 2006 Chamber's Banking and Financial Services Committee hosted several interesting meetings with representatives of partner organization and international institutions including but not limited to:

• Business Luncheon with

Mr. Oleksandr Shlapak, Head of the State Treasury of Ukraine. Mr. Oleksandr Shlapak presented the policy and reforms the State Treasury of Ukraine planed to implement in 2006, new projects and initiatives, which he as a Head of the State Treasury consider as priority in nature as well as the dynamics of the relationship and cooperation with the National Bank of Ukraine and Ministry of Finance.

- Meeting with Mr. Vladimir Daviduk, State Department on Financial Monitoring regarding Law of Ukraine #3163-IV "On changes to some legislation regarding improvement of regulation of international cooperation in the sphere of preventing financing of terrorism" and it's implementation.
- · Meeting with Mr. Denis Fudashkin, **Director of the Tax and Customs Policy Department of the Ministry** of Finance. Mr. Fudashkin was invited to present on the VAT electronic reporting system as well as changes in corporate taxation and insurance sector. Mr. Fudashkin also stated that there will be no abolishment of VAT in the nearest future and added that it is a principal question under discussion at the Ministry of Finance. The major problem, from Mr. Fudashkin perspective, with the implementation of the VAT electronic reporting system is the postponement of liabilities against future periods. To avoid this problem the Ministry plans to work out the provision that all the VAT sums should be declared by a certain period. Mr. Fudashkin said that the Ministry of Finance would focus on implementation of taxation of interest on deposits, and changes in taxation of provisions. He also informed that insurance companies,

except life insurance, should be subject to the general system of taxation.

- Meeting with Ms. Angela Prigozhina, World Bank, provided a very detailed informational update on the financial sector including banking, insurance and leasing sectors. Ms. Prigozhina briefed on non-State pension funds and mortgages which is 4% of GDP. As to banking sector, the concentration of banks grew in total there are 165 banks, 5 new banks came into market, 23 banks with foreign capital, 10 larges banks have 52% of assets of the banking sector.
- Meeting with Ms. Natalia Guduma, General Director of the League of Insurance Organization of Ukraine participated in the discussion of the current situation regarding ratings for banks. Members were informed that 25 banks are already rated: 15 are rated by Credit Rating and 10 are rated by international companies. Members agreed that after registration of international rating companies in Ukraine, the problem of the rating monopoly was finished.

Examples of major issues that the Banking and Financial Services Committee was actively involved in included but is not limited to:

• Law of Ukraine #3163-IV "On changes to some legislation regarding improvement of regulation of international cooperation in the sphere of preventing financing of terrorism" - this document requires financial institutions, including banks to stop a transaction, when and if in such transaction there is a reference, i.e. a name that matches with a "black list" to be ...

Services Committee. Main issues included the types of organziations that should be required to receive ratings as well as the situation with only one rating provider. When the discussion started only one rating agency worked in Ukraine who had a monopoly position on the market and later in 2006 three additional international rating agencies entered the market and the monopoly issue

was resolved.

- Draft Law on #2135 "On Amending Some Laws of Ukraine (regarding establishment of rule for development of financial services markets and protection of interests of many marker players - if adopted cancels obligatory credit ratings. The Committee agreed that in some instances there is a good reason to require credit ratings and it assists in the protection of the depositors / insurance subscribers which necessitates inter alia rating to be developed / imposed. Committee Members addressed Mr. Poroshonko, Head of Verkhovna Rada Committee on Finance and Banking Activity with the strong position against the adoption of the Draft Law.
- Short-term derivatives the Banking and Financial Services Committee continued to approach the NBU on the development of short-term derivatives in the market and on the request of the NBU has sent all necessary documentation needed by the NBU regarding adoption of short-term derivatives.



- VAT electronic invoices the question of VAT electronic invoices was covered and Members were informed that a pilot project was created and was implemented by the Ministry of Finance. The Chamber Policy Team contacted the appropriate person in the Ministry for more clarification and updates on progress and to make sure the Committee can get involved at an appropriate time to ensure the system works well for the Membership.
- Draft Changes to Instruction on Cashless Calculations in Ukraine in National Currency, adopted by NBU Resolution #22 the amendments will give power to the tax authorities to withdraw the debt amounts from taxpayer's bank accounts without a court decision or even special information. Chamber's Banking and Financial Services Committee addressed the NBU and STA with the Committee's position against adoption of such changes.
- · Banking and Financial Services Committee was the advisor to the Banking and Non-Banking Financial Institutions Working **Group of Foreign Investment** Advisory Council (FIAC) under President Yushchenko and considered the FIAC related Presidential Decree #300 dated April 10, 2006 "On High Priority Measures in the Area of Investment Activities" that contains a majority of reform items that were suggested by the FIAC Working Group. After signing of the Decree the Committee continues to monitor implementation by the Government.

- ... developed and provided to the Ukrainian financial institutions by the Government of Ukraine. And, if those institutions let such transaction occur, their managers would be criminally liable. Banking and Financial Services Committee Members fully supported the idea and the goal of the law, but at the time did not see any real mechanisms on how to implement it effectively. The Banking and Financial Committee conducted several meetings with representatives of the State Department of Financial Monitoring as well as the NBU on the matter to ensure that all software and mechanisms developed will work well together allowing the system to operate effectively.
- · Development of Leasing in Ukraine - during the year the Committee discussed leasing issues many times as well as listened to a presentation by Mr. Richard Caproni from a USAID project working on capital markets who informed Members of the Committee on recent developments within the leasing market and Draft Law "On Amending of Some Legislation on Taxation" (regarding leasing) # 2016, dated August 23, 2006 which was supported by the Committee Members. The Committee's position was addressed to the Verkhovna Rada Committee on Finance and Banking Activity.
- Credit Ratings in Ukraine credit rating issue was an ongoing issue that was discussed at the meetings of the Banking and Financial

The Business Management Education and Training Committee's Mission is to positively influence the working environment of educational and training organizations by clarifying issues and, when necessary, advocating for change. It serves as a bridge of understanding and cooperation between the business and education communities - raising awareness of the value of education and training, identifying key needs of business, and promoting services that satisfy those needs.

The Business Management Education and Training Committee started 2006 with a presentation on

"Professional Qualifications in Accounting and Finance: Their Role in Business"

by Mr. Brian Hock, HOCK Accountancy. During the meeting Mr. Hock informed the participants what types of qualifications are available, what each of them means as well as what benefits employees and employers gets from them.

During the year the Business Management Education and Training Committee focused on creation of a matrix of business community needs vs management education and training services providers.

For that reason a joint meeting of Business Management Education and Training and HR Committees was organized. The meeting was designed to obtain from the HR Committee Members information on their current and future human resource needs in regards to business management education and training. Also, during the meeting par-

ticipants figured out that there is lack of awareness among the Members in regards to the number of services available on the market.

Members of the Business Management Education and Training Committee developed a matrix, which has all the information about Chamber Members who provide trainings with the list of services that they provide.

The Business Management Education and Training Committee Members also focused on the possibility and needs of advocacy in changes to the educational system to properly align it with the with needs of business. Members highlighted a couple of changes that they consider to be rather important, the first one is that all the education programs should be inline with current professional needs and time, and the second is that programs should be more practice oriented and should incorporate more trainings.

The Customs and Transport Committee's Mission is to provide assistance to the Ukrainian customs and transport authorities to meet EU/US standards of processing and clearing goods on permanent / transit / temporary entries. The Committee sees their long-term objectives in the implementation of: E.D.I. Electronic Data Integration between customs and brokers; free zone area for goods and materials and introduction of electronic pre-clearance procedure. The Customs and Transport Committee short term objective includes: simplification of customs formalities for personal belongings; clarification of laws interpretation; faster communication process in case of questionable formality; random checks for express courier shipments (import and export); regional consolidation of customs clearance; invitation of official customs officers by the customs authorities in Europe and the U.S. to observe and train on EU and U.S. systems.

The Chamber's Customs and Transport Committee serves as a platform to network and exchange recent news regarding changes in customs legislation and procedure as well as transport sector. In 2006 the Committee continued the active cooperation with Ukrainian customs authorities and conducted several meetings with senior officials as well as actively participated in the Public Council under the State Customs Service and worked on changes to the legislation on customs tariffs and procedure.

Examples of major issues that the Customs and Transport Committee was actively involved in included but is not limited to:

- Import of special scientific and technical education literature and customs duties for it. Members agreed that such changes should be developed by the Committee and provided to the Cabinet of Ministers or Verkhovna Rada Committee on Education and Science
- •"White lists" of importers these so called white lists were of interest to the Members of the Customs and Transport Committee and for that reason the Chamber Policy Team organized the meeting with representatives of the State Customs Service of Ukraine

- Mrs. Iryna Liadenko, the Head of the Customs Cost Department and Mr. Sergiy Shut, the Head of Division of the Customs Cost Department. Mrs. Iryna Liadenko and Mr. Sergiy Shut updated the Members on the details of the favorable customs regime and all conditions for enterprises to be a part of the so-called white list during customs clearance procedures and clarified what criteria they are using for including companies on to the white list. Members suggested that one of the criteria can be banking guarantee (customs bond guarantee) that will ensure the payment of all the duties if the company imports goods and will simplify the procedure of custom clearance.
- Cooperation with other Chamber Committees including but not limited to the IT Committee on such issues as definition of software, procedures of software import, methodology of calculation of royalty, etc.
- Amendments to the Customs Code regarding tariffs and implementation of pre-clearance procedures as well as increasing the value of shipments exempt from customs for express carriers up to \$200.
- Law of Ukraine "On Chemical Sources of Electric Energy" # 3503-IV dated February 23, 2006 that came into force on July I, 2006 and stopped import of any chemical sources of energy due to the fact that after of adoption of the law the import of such products can be done only with licensing. The procedure of obtaining licenses had not been developed as of July I, 2006 and the Chamber's Customs and Transport Committee addressed the issue to Prime Minister Yekhanurov and the problem was rapidly resolved

The Chamber Policy Team continues to be an active participant of the State Customs Service Public Council providing Customs and Transport Committee Members information on new legislation and legislative initiatives of the State Customs Service as well as providing an opportunity for Committee Members to supply their comment and amendments to draft legislation.

At the meetings some issues that are important for business operations were discussed including procedures of temporary holding on the special customs storages, phytosanitary control procedures and sanitary customs regulations. The Public Council successfully addressed the State Customs Service, with input from the Chamber, asking to exclude pasteboard packaging from the list of commodities for phytosanitary control.

The Mission of the Chamber's Healthcare Committee is to improve Ukraine's business environment in the healthcare field, exchange of relevant and timely information, organizing discussions and taking joint actions aimed at promoting the commercial interests of Member companies. Among the issues the Healthcare Committee addressed is registration and licensing procedures in two primary spheres: registration procedures for pharmaceutical companies and licensing for pharmaceutical wholesalers. Since its creation the Committee has been working in cooperation International Pharmaceutical producers as well as the US Embassy Foreign Commercial

The key issues for 2006 were registration procedures, customs process-

ing, and tender purchases, data exclusivity, 20% VAT on clinical trials, import of medical equipment and batch control as well as Intellectual Property Rights protections including the problem of patent infringement.

• Open Committee Meeting with Mr. Yuriy Konstantinov, Head of State Service of Pharmaceuticals and Medical Devices - during the meeting Mr. Konstantinov updated participants with his vision of the priorities and issues that need to be changed to improve the pharmaceutical and medical device market. Konstantinov also shared information that the main focus of the State Service is standardization of all processes and implementation of quality management as well as certification. The Head of the Service also highlighted that there should be a process approach and never a human factor to make these decisions. Mr. Konstantinov said that he had signed the Order on Creation of Science and Experimental Institute on Pharmaceuticals and Medical Devices as well as the changes to article 4 of the Law of Ukraine On Permit Members asked Mr. Systems. Konstantinov questions on the

national list of drugs, terms of registration, standards of treatment, import of equipment for clinical trial, confidentiality issues and many others on new procedures in relation to the adoption of the Order on Creation of Science and Experimental Institute on Pharmaceuticals and Medical Devises.

Draft Law #2399 Changes of the Article 9 of "Law on **Drugs** (Medicines)" - this Draft Law was one of 16 drafts initially proposed by President Yushchenko as those which are necessary to be adopted by Parliament to proceed with the WTO accession process and registered in the Parliament on October 20, 2006. The Committee expressed support of the draft versus another variant, which was placed for public discussion on the web site of the Ministry of Healthcare.

•Cabinet of Ministers Resolution #902 - at the end of last year the Chamber's Healthcare Pharmaceutical Sub-Committee addressed the Government to suspend Cabinet of Ministers Resolution #902 until 2007.

The Chamber's HR Committee continued to accomplish their Mission of sharing experience, knowledge and skills with other HR professionals; promoting the professional development of Members through exposure to new knowledge, skills and information resulting in the enrichment of the personnel function within Member's respective organizations and increasing awareness of HR throughout the Chamber Membership. The HR Committee continued to meet regularly serving as an excellent networking, information and experience-sharing forum for all interested Chamber Members. A wide range of presentations were made during the year providing the Committee Members with valuable information they find useful in their day-to-day HR needs.

In 2006 participants in the HR Committee had access to the following presentations:

- "Utilization of Assessment Center in the Practice of HR Management" made by Ilona Sharova, Irina Grabskaya and Katherine Ostapchuk, Hudson Human Capital Solutions.
- "Peculiarities of searching for personnel in the Internet" by Ms. Marina Makoviy, Director and Ms. Tatiana Topchiy, PR manager, Headhunter. After the presentation participants held an active discussion of the information presented and addressed questions regarding placement of vacancies and resumes on different job sites, as well as talked about common mistakes of employers when reading resumes and choosing applicants.

- "Board Simulations: A New and Innovative Approach to Business Education" by Mr. Brenday O'Malley, Development Manager of CBSD/Thunderbird Russia. After the presentation participants discussed a couple of case studies and posed questions to the speaker.
- "Payroll outsourcing. Staff leasing (Temporary staff)" by Konstantin Tkachenko, Acumen Outsourcing
- "Toastmasters is it a proven tool or methodology?" by Vitaly Fedchuk and Victor Koszarny, Chamber's Toastmasters Club.
- "Individual Development and Career Planning", Julia Prisada, Cargill and Anna Radysh, JTl.
- Two presentations on personal income tax for U.S. expatriates. Olga Gorbanovskaya and Halyna Khomenko, Ernst & Young gave first presentation with an overview of Ukrainian personal income tax legislation with a focus on those issues, which might be of interest for US expatriates. The second presentation was devoted to U.S. Tax Increase Prevention and Reconciliation Act and was presented by Peter Reinhardt, Human Capital Partner and Anton Ionov, Human Capital Manager, Ernst & Young in Moscow. In the presentation they covered the following questions: general overview of U.S. taxation and avoidance of double taxation, highlights of the old rules - foreign earned income and housing exclusions, and informed on key changes in U.S. legislation and the impact on U.S. expatriates and businesses - Ukraine specific and gave examples and statistics. After presentations the floor was open for questions during which participants tried to see cost estimates planning opportunities. Participants of the Committee agreed

to check what can be done to amend this Law and to make U.S. expatriates compatible on the employment market compare to the expatriates from other countries. The Chamber continues to work on this issue with our partners in Washington D.C.

Chamber's HR Committee and Chamber Member American Life Insurance Company AIG Life hosted an HR Conference "Employee Benefits" on May 11th, 2006. The Conference was opened by welcoming speeches of Mr. Pavol Norulak, General Manager of ALICO AIG Life Ukraine and Mr. Jorge Zukoski, President of the Chamber. The introductions were followed with a presentation by Mrs. Mandi Veil, Regional Vice President, Group Management Division Central and Eastern Europe, ALICO AIG Life Europe entitled "Review of employee benefits in Eastern Europe and AIG Life experiences and expertise". Mrs. Mandi Veil's presentation was followed by a presentation of review of employee benefits in Ukraine by Olga Gorbanovska, Human Capital consultant of Ernst & Young Ukraine. The Conference was a forum and great networking opportunity for HR specialists of difference fields of business.

The Human Resource Committee also conducted a joint meeting with the Business Management Education and Training Committee. The meeting that was dedicated to obtaining from HR Committee Members, as representatives of the business community, information on their current and future employment needs as to business management education and training for further utilization of this information for developing a matrix of business community needs vs. management education and training services providers.

The Chamber's IPR Committee was created with the Mission to advocate on behalf of the Chamber Members to protect Intellectual Property Rights in Ukraine. The IPR Committee's goals and objectives include:

- I.Analyzing existing IPR-related law enforcement mechanisms in Ukraine
- 2. Organizing the lobbying activities to change the current Ukrainian legislation to ensure compliance with international standards and agreements with the simultaneous
- 3.Provision of information and to create networking opportunities to discuss issues related to the IPR development worldwide and in Ukraine
- 4. Establishment reliable multi-channel relationships with Ukrainian law enforcement agencies and business community to ensure the effective lobbying process related to Intellectual Property Rights
- 5. Education of companies, government sector representatives and media in Ukraine on the role and importance of intellectual property rights for investment, economic growth and tax revenues
- 6. Identification of key problems that require immediate resolution

The IPR Committee started 2006 with a strategy meeting that developed 3 priority issues that were to be achieved during the year. To gather relevant information from the Membership a survey was developed and implemented and after the survey was completed the fol-

lowing priority areas were adopted by the Committee:

- Data exclusivity as a very important issue for many industry sectors including pharmaceutical companies especially within the framework of WTO accession
- Issues concerned with IT and the Hi-Tech industry such as license agreement, ring tone definition as well as many others
- Parallel import and unfair competition in the IPR sphere. Members were working on the position to address to the Government

The Chamber IPR Committee defined the State bodies that the Committee will continue to work closely with in 2007. They include but are not limited to:

- State Department of Intellectual Property
- Higher Economic Court, specifically its Specialized IPR Chamber
- Antimonopoly Committee
- State Customs Service
- Verkhovna Rada and its Committees

Meeting of the Enforcement Cooperation Group in State **Department of Intellectual** Property - the Chamber Policy Team participated in the Second Meeting of the Enforcement Cooperation Group in State Department of Intellectual Property. The meeting gathered representatives of Ministries and other executive power institutions that are the Members of the Coordination Council on fighting the violation of IPR as well as representatives of international organizations like IFPI and others. The goal of the meeting was the intensification of cooperation between Ukrainian Government and international industry of copyrights. Among the issues on the agenda, the Group discussed currents situation in IPR protection sphere, progress that took place from the last meeting, measures that SDIP is taking to improve the system of IPR protection. Mr. Paladiy stated that regional coordination councils have been very active during last half a year and that during first four month of 2006 inspectors of SDIP had conducted 292 audits and issued 142 records on administrative violation, also 61 criminal cases were opened. During 2005 50 million control stamps were issued, which is 5.5 million more than last year. These positive dynamics highlight that the number of legal production is increasing. Participants also discussed the activity of collective management organization that SDIP registered in the number of 11. Participants agreed on further cooperation with State Department of Intellectual Property on intellectual property right protection issues.

Public Council under the State Department of Intellectual Property Rights - the Chamber Policy Team actively participated in the meetings of the Public Council under the State Department of Intellectual Property Rights. The agenda of the meetings included consideration of new documents that regulate relations arising in connection with acquisition and use of property rights to marks for goods and services in Ukraine, as well as discussed the Law of Ukraine "On the Protection of Rights to Marks for Goods and Services" that required amendments as the original provisions are not in line with current legislation, including the Civil Code of Ukraine.

The Mission of the Information Technologies Committee is to improve the environment for the further development of a sustainable and well-regulated Information Technologies market in Ukraine.

After creation of a Development Strategy for the IT Industry in Ukraine, within the framework of President Yushchenko's Investment Advisory Council (FIAC), the IT Committee continued to monitor the situation with implementasuggested changes. Throughout the year the Chamber's IT Committee has participated in difforums such Outsourcing forum, Technobridge and others that were industry oriented and designed to highlight the competitive advantages that the Ukrainian IT market has to offer.

A major focus of the IT Committee in 2006 was changes in the educational system of IT specialists. Committee Leadership conducted a series of meetings with senior officials including Zhebrovsky, Deputy Minister of Education and Science, representatives the Center of Innovation Technologies and Meaning of Education. During the meetings the Chamber Committee Leadership and Policy Team shared opinions gathered from the Committee on problems with IT specialist educational programs, discussed curriculums and agreed on further work on designing standards for the educational programs for IT specialists. After these series of meetings the IT Committee sent their comments and amendments to the suggestions of the Ministry of Education and Science Draft of list of bachelors degrees (majors).

Draft Law of Ukraine #9179 "On Changes to the Law of Ukraine on State Informatization Program" - would have required all computers, including servers to have integrated system "Slovnyky of Ukraine". The Chamber's IT Committee addressed their disagreement with this piece of legislation to the Speaker of the Parliament, Mr. Lytvyn aas well as other lawmakers and as a

result the Draft Law was not adopted. In the second part of the year the IT Committee Leadership suggested a new format of operations - Expert Group. The Committee agreed that an Expert Group on IT means that Members do not have to meet on regular basis and can meet when pressing issues are identified. Participants were proposed to be the voice of the industry and when needed, able to comment on the current status and prognosis for the development of the IT industry.

Cooperation with IT Associations.

Presentation on the operation of IT Ukraine Association was given by Mr. Igor Menzebrovsky, representative of IT Ukraine to the Chamber's IT Committee Members. In the presentation he touched upon possible ways of cooperation between two organizations in coordination of cooperation of Government activities in the IT sphere.

Round Table discussion "Ukraine's Competitiveness in the Global Knowledge-Based Economy: meeting with Google" - members of the Chamber's IT Committee participated in the Round Table and had the chance personally to meet representatives from Google.

The Chamber's Legal Committee was created with the Mission to be a forum for professional exchange among attorneys from law firms and corporate entities. Members of the Committee represent a broad spectrum of legal professionals working in Kyiv. One of the Committee's main activities is to work in conjunction with other Chamber Committees when they need to address issues with specific legal ramifications.

In 2006 the Legal Committee organized meetings, cooperated with other Chamber Committees and participated in various Working Groups including but not limited to the following:

• DEVELOPMENT OF FRANCHISING IN UKRAINE – the Chamber's Legal Committee listened to the presentation on development of franchising in Ukraine given by Mrs. Svetlana Koba, OSCE with the summary and suggestions to improve legislation on franchising agreements in Ukraine.

- •MERGERS AND ACQUISITION members of the Committee actively participated in the Chamber M&A Working Group and provided input to the White Paper that was a direct deliverable of the M&A Working Group that was presented to relevant Government and other appropriate authorities.
- COMMERCIAL DISPUTE RESOLUTION STUDY Mrs. Patricia Shaughnessy, IFC international consultant introduced the recently launched Commercial Dispute Resolution Study which is being done to identify problems and benefits in existing methods of dispute resolution and the demand / interest in alternative methods of commercial dispute resolution (ADR) in Ukraine.

•Working Group Against ILLEGAL CORPORATE RAIDERS -Legal Committee Members initiated the creation of the Working Group Against Illegal Corporate Raiders. Participants within the Working Group includes leading lawyers from prominent law firms in Ukraine and as a result a draft action plan and contents of the White Paper were developed. The Chamber then gathered input from the Membership on the issues and as a result developed and disseminated a White Paper as discussed. The White Paper then was presented to appropriate State authorities including Parliament, Cabinet of Ministers, judicial bodies, etc. as well as relevant diplomatic and donor missions to address the recent increase of illegal corporate raider attacks. Chamber has shared the White Paper with other interested stakeholders and organizations to

solicit their support.

The Chamber Real Estate Committee sees its goals and objectives in the following spheres if activity: information and experience sharing between the Chamber Members involved in the real estate sphere; cooperation with corresponding legislative and executive bodies with the objective to introduce necessary amendments into Ukrainian legislation which in turn will promote real estate development in the country; reduction of the bureaucratic obstacles involved in real estate transactions; transparency

in real estate transactions; facilitation of foreign investment in Ukrainian real estate development projects; as well as availability of long term financing for the real estate projects.

In 2006 the Chamber's Real Estate Committee hosted a meeting with Mr. Pavlo Kachur, Minister of Building, Architecture AND HOUSING AND COMMUNAL SERVICES OF UKRAINE. Minister Kachur started an active and focused dialog with Chamber Members and during the meeting he provided the Membership with his vision of the priorities and issues that should be addressed to improve the investment climate and attract new investors within the real estate and construction markets. The Minister discussed the main focus of the new Ministry under his leadership and agreed to have his Public Policy teamwork with

the Chamber's Real Estate Committee and Policy Team to formulate relevant policy initiatives to stimulate the construction market in Ukraine.

The Real Estate Committee was actively involved in work of Public Council under the State Property Fund as well as into cooperation with related organizations and State Authorities.

STATE PROPERTY FUND OF UKRAINE PUBLIC COUNCIL - among the issues of discussion of the Public Council was the update on the State Program of Privatization, draft legislation that State Property Fund planned to adopt in regards to the further development of the stock market as well as reports by State Property Fund on achievements and future plans.

The Chamber's Tax Committee envisages their primary goal in the promotion of reform and improved application of the taxation system in Ukraine, recognizing that a predictable, equitable and effective tax system is a significant factor both in general facilitation of business and in positive development of the economy of Ukraine and facilitation of information-sharing on tax issues between the Membership. Top professionals from advisory firms and business entities have formed the core group of the Tax Committee. This year the Tax Committee continued to serve as the forum for Chamber Members to discuss tax issues that impact Chamber Committees actively involved both in lobbying and networking activities.

Examples of major issues that the Tax Committee was actively involved in included but is not limited to:

•VAT on SERVICES PROVIDED FOR NON-RESIDENTS - after the discussion of the issue internally within the Tax Committee as well as after the meeting with the head of the State Tax Administration, Mr. Olexander

Kireev, Chamber Members agreed to work towards clarifying the situation with VAT taxation of services provided for non-residents.

•VAT REIMBURSEMENT -VAT reimbursement is an ongoing long-term issue that the Chamber's Tax Committee in conjunction with the Agricultural Committee has been actively engaged within that was rather successfully resolved in the recent past. Unfortunately, in the middle of 2006 problems with VAT refunds again emerged on a large scale and the Agricultural Committee addressed Mr. Mykola Azarov, First Vice-Prime Minister to work towards a resolution of this contentious and ongoing issue. The Chamber was told that the Government had not permanently stopped VAT reimbursement but was in the process of conducting audit procedures due to a claim that a large number of violations in the sphere had taken place earlier in 2006 as well as in 2005. Despite the government imposed discontinuation of VAT refunds during the audit procedures, some reimbursements were being executed in a non transparent or equitable manner leading the Chamber community to continue to advocate for the improvement of the VAT reimbursement procedure. The Chamber will continue to address all relevant decision makers including the Cabinet of Ministers. Presidential Secretariat. State Tax Administration and the Council of National Security and Defense on the matter.

•Mergers & Acquisitions - Tax Committee Members were one of initiators of the creation of M&A Working Group. Members worked on taxation treatment of M&A and corporate reorganization transactions in Ukraine that may pose significant obstacles to investments. They also covered dividends and other non-liquidating distributions connected with an M&A transaction and agreed on proposals on formation of the company including contribution of cash and property. The Committee also worked on amendments to Corporate Income Tax Law and VAT Law in regards to M&A transactions.

•DRAFT TAX CODE -Committee Members were actively involved in discussion of the Draft Tax Code; they submitted their questions, comments and suggestion to the Chamber's Policy Team for submission to the State Tax Administration. Also, the Chamber Policy Team organized a meeting with representatives of the State Tax Administration that were working on Draft Tax Code Mrs. Larissa Trofimova, Director of Legal Department of State Tax Administration and Oleg Nikitin, Leading State Tax Inspector participated in the meeting.

•STATE BUDGET 2007 - the Draft 2007 State Budget was a priority for consideration and discussion by the business community in Ukraine. The Chamber Policy Team took part in the State Tax Administration Public Council meeting devoted to the ...





...discussion of the Draft State Budget 2007 and updated the Membership in regards to outcomes of the meeting.

In 2006 the Tax Committee of the Chamber held several meetings with State authorities including but not limited to:

•MR. OLEXANDER KIREEV, HEAD OF THE STATE TAX ADMINISTRATION - the Tax Committee meeting was dedicated to the discussion of VAT issues such as VAT processing, discrepancies in VAT legislation, VAT in the Draft Tax Code and reimbursement of VAT. One of the Chamber Policy Priorities in 2006 was Tax Reform in Ukraine and in particular improving of VAT administration, implementing of Social Unified Tax and Automating of the Tax Reporting System.

•MRs. LARISSA TROFIMOVA, **DIRECTOR OF LEGAL DEPARTMENT** OF STATE TAX ADMINISTRATION AND OLEG NIKITIN, LEADING STATE TAX INSPECTOR. The meeting was dedicated to the discussion of the Draft Tax Code. Members were updated on the background of the creation of the Draft Tax Code and she also stated that it would be optimistic that this Draft Tax Code will come into force starting from 2008. Ms. Trofimova also said that the State Tax Administration at the time was in the process of discussion of the Draft and had incorporated many suggested changes from the Chamber. The Chamber had developed additional comments and amendments and presented them to the speakers after the meeting.

•During the year the Chamber continued to be an active participant of the **PUBLIC COUNCIL OF THE STATE TAX ADMINISTRATION** and discussed VAT reimbursement, introduction of electronic VAT procedures, participated in the public discussion of the Draft Tax Code, as well as considered many others State Tax Administration legislative initiatives. Also, the Public Council with participation of the Chamber discussed the implementation of Social Unified Tax and Automating of the Tax Reporting System.

The Telecom Committee's Mission in lobbying the interests of the Chamber Member companies operating in the Ukrainian telecom industry by providing the most efficient solution to the various challenges faced by its Members. The Committee works in close conjunction to pursue mutual goals that stimulate the creation of a necessary environment for efficient development of the telecommunications sector.

At the beginning of 2006 Members of the Telecom Committee created two sub-committees:

•CERTIFICATION SUB-COMMITTEE the Certification sub-Committee was created to focus on telecom equipment certification issues. At the beginning of the year the Sub-Committee gathered senior management from vendor companies that face certification issues in their every day business. The gathered executives decided to develop and present an action plan to harmonize EU and Ukrainian standards of certification of telecom equipment as well as to prepare examples of overlapping Ukrainian certification with certification carried out in EU. They also gathered information on the volume of certification bodies, terms for receiving certificates; certification costs for different types of equipment in the EU and U.S. and implementation of EU Directive 1999/5/EC. Ms. Olga Zabavchyk, Ericsson, made a presentation on Certification issues.

•Interconnect Sub-Committee in 2006 the Interconnect Sub-Committee focused on a new settlement order including new boundary tariff approval and implications, direct numbering issues and the impact of Ukrtelecom's new non-monopoly status regarding international and intercity communications. Members of the Sub-Committee participated in the international conference for National Commission Communication Regulation and Telecom industry Members with invitation of independent consulting companies and regulators from European countries on the process of tariffs and interconnect rates utilized in European countries. Also, the Sub-Committee worked on the direct numbering issue and agreed that there should not be joint action of the Committee in that respect.

All meetings of Telecom Committee start with a Telecom Industry Regulation update that is very timely and informative. After creation of the Public Council under National Commission of Communications Regulation (NCCR) and subsequent involvement of the Chamber's Policy Team it became of interest to Telecom Committee Members that each Committee meeting also contains an update from the Chamber on the activity of the Public Council.

During the year Telecom Committee was the forum and useful source of information. Members had the chance to listen to the following presentations that were followed up by actions on the issue:

- •Presentation on 3G by Mrs.Olga Dubovik, Astelit Olga presented 3G licensing policies and strategies in different countries, as well as licensing requirements. Members discussed the letter sent to the Prime Minister on 3G and worked on following up on this issue to ensure all interested mobile telecom providers have access to 3G licenses in clear and transparent tenders.
- •Presentation on interconnect methodology by Mr.Yuri Makarenko, UMC during which he presented methodology to determine interconnection rate, pros and cons of LRIC and FAC models as well as EU countries experience of using these systems
- •Presentation on Wi-Max given by Mr. Yuri Chuikov, UHT
- •Presentation on National Roaming by Mr. Kyryl Kozlov, Golden Telecom Ukraine
- •Presentation on CDMA development in Ukraine by Mr. Vitaliy Vorozhbit, General Director of Ukrainian Telesystems
- •Presentation on Direct Numbering by Anna Podvysotskaya, UMC
- •Presentation on Fixed-mobile convergence (FMC) Andrii Droniuk, Golden Telecom Ukraine

At the beginning of the year, the Chamber's Telecom Committee successfully addressed President Yushchenko regarding recent changes in legislation that would increase... ...the risk of cancellation of licenses for

mobile operators asking to veto the legislation and send it ...back to the Verkhovna Rada with comments from the Chamber's Telecom Committee.

In 2006 the Telecom Committee conducted several meetings with officials including but not limited to:

•Mr. Yatsuk, Head of the **Department** State of **Informatization** and Communication - under the Ministry of Transport and Communications in Ukraine. At the meeting Mr. Yatsuk discussed the split of responsibilities between the State Department of Informatization and Communication, NKRZ and the Transport **Ministry** of Communications of Ukraine. He also talked about recent initiatives of the

Department regarding distribution of radio frequencies and the Plan of use of those radio frequencies. Mr. Yatsuk also answered questions from Members on NDC (national destination codes) shortage in Ukraine, on physical protection of primary communication network (cables), certification procedures simplification and national roaming. The participants agreed to continue such meetings and cooperation including developing documents together and initiating changes in legislation on telecommunication.

•Mr. Vitaliy Korzh, Verkhovna Rada Deputy - the meeting was mainly dedicated to the discussion of the Draft Law "On Telecommunications". At the beginning of the meeting Deputy Korzh updated the participants on the his-

tory and background of the creation of the Draft Law, and main provisions of the Draft. After a short presentation, Andrii Droniuk, Telecom Co-Chair, Committee Golden Telecom, updated the attendees on the Committee's activity and priority issues that Committee works on. After his presentation the floor was open for questions from the Members and Mr. Korzh provided informative answers. At the end of the meeting it was agreed that the Chamber will prepare comments on the Draft Law and will submit it to Mr. Korzh for his consideration. It was also agreed that the Chamber will be included in the Working Group on the Draft Law and will meet shortly.

TRAVELAND TOURISM COMMITEE

The Chamber's Travel and Tourism Committee was created with the Mission to encourage the participation of the Chamber Members in an organized policy initiative to promote Travel and Tourism related issues in Ukraine. The Travel and Tourism Committee's goals and objectives include increase of Ukraine's participation in international travel and tourism organizations and forums; promotion of the development of the Ukrainian business and leisure hospitality infrastructure; simplification of the bureaucratic requirements for foreigners to travel in Ukraine; increase the ready availability of international standard business facilities; promotion of Ukraine as a desirable destination for international holiday travelers; sharing knowledge and among experience Chamber Members involved in the travel and hospitality arenas.

In 2006 the Travel and Tourism Committee maintained their close relations with the State Tourism Administration of Ukraine and hosted Business Luncheon with MR. ANATOLIY PAKHLIA, HEAD OF THE STATE SERVICE ON TOURISM AND RESORTS OF UKRAINE. Mr. Pakhlia shared information regarding the current activities and priorities of

the State Service on Tourism and Resorts and his thoughts regarding the 2006Action Plan and new legislation that the State Service plans to initiate. He also provided more details on the structure and functions of the State Service under his leadership.

Among the issues of discussion of Travel and Tourism Committee were:

- •CHANGING OF CONDITIONS OF INTERNATIONAL AIRLINE TICKETS SALE AND ADOPTION OF ELECTRONIC TICKETS Valeriy Luyk, Sky Travel BTI, Committee Chair, made a presentation showing advantages of the new procedures of air ticket sales and changes in service fees. As to electronic ticketing procedure, it makes travel easier and more comfortable for the tourist. She also highlighted that some of the airlines have stopped working with paper tickets.
- •RAILWAY TICKETS SALES ISSUES participants highlighted the following problems: absence of booking of railway tickets, necessity of passport for buying railway ticket, inability of doing group orders, as well as a lack of general service orientation. Members agreed that without good railway booking system, development of tourism in Ukraine will procrastinated.
- •DRAFT RESOLUTION ON NEW PROCEDURE FOR PRODUCTION AND REGISTRATION OF AIR TRANSPORT DOCUMENTS -

the major hesitations regarding the

Draft were in obligatory registration of ticket stock and abolishment of electronic ticket issuance. After the meeting the Chamber Policy Team, through their channels, worked on the issues and received information that the State Administration of Ukraine for Aviation Safety Oversight was working on changes and explanations to the Draft Resolution including comments and suggestions, which are aimed to clarify many questionable issues. It says that Resolution, if adopted, will only apply to paper tickets to those companies from countries that do not have bilateral agreements with Ukraine shielding Member airlines from these onerous and unnecessary regulations and allowing electronic tickets to continue to be issued. The Chamber will continue to work on this issue to ensure that international best practices and transparency is incorporated into the regulatory system that impacts the airline industry in Ukraine.

- •The Travel and Tourism Committee addressed the Verkhovna Rada Committee on Family, Youth Policy and Tourism with the suggestion of creation of sub-Committee on Tourism.
- •Chamber also followed up on the differing **VISA REGIMES** and updated Committee Members on the changes in the procedure, simplification of the process.







In 2006 the Chamber was proud to have organized more than 70 highly successful Networking events.

As the Chamber continues to strive to constantly improve value added services provided to the Membership, the Chamber has developed a dedicated Events Team and they work on the following grouping of events that have different target markets and fulfil different needs: Business Networking, Social / Family, Team Building and Corporate Social Responsibility related events. The Chamber Event Team prides itself in being innovative and in 2006 they launched several new exciting projects such as Travel with the Chamber, the Marketing Club and expanded the activities focused on the Young Professionals Network.

CORPORATE SOCIAL RESPONSIBILITY COMMITTEE OF THE BOARD OF DIRECTORS

In 2006 a new Board of Directors Sub-Social Committee Corporate on Responsibility (CSR) was established. Through the program, the Chamber and UCAN have worked with more than a dozen Ukrainian non-profits to creatively address urgent and recognized needs in their communities. Carefully selected Ukrainian organizations have utilized these funds to meet priority social needs and create entrepreneurial projects that serve to further finance their work.

Charity funds have been distributed to worthy Ukrainian organizations through two grant programs: social needs grants and social enterprise grants. Both programs direct corporate dollars to apolitical organizations that are judged to be in a unique position to create positive change for disadvantaged or disenfranchised people in their communities.

SOCIAL ENTERPRISE GRANTS are being used by Ukrainian organizations to develop entrepreneurial projects to generate funds for their causes.

SOCIAL NEEDS GRANTS have been used by Ukrainian organizations to address urgent needs in their communities and involve local citizens and businesses in their charitable activities.

SOCIAL ENTREPRENEURSHIP GRANT COMPETITION.

UCAN in partnership with the Chamber announced an Innovation Grant Competition for Social Entrepreneurship. Social Entrepreneurship grants are for non–governmental non-profit organizations that have ideas for or are experienced in raising revenue from their activities or in cooperation with business structures or private entrepreneurs; and/or from opening a new business or developing the current one.

Social Entrepreneurship grants are aimed at enhancing the financial viability of the non-profit organizations and at successful accomplishing of their social mission by implementing of the market mechanism and entrepreneurship skills into their activities.

Social Entrepreneurship grants will allow the Ukrainian organizations:

- to provide more stable and independent financing for the organization's activities towards its mission;
- to achieve "social effect" aiming at improving the quality of life of the targeted audience;
- to develop and implement new approaches to the social problems /issues solution.







The Chamber and the Global Compact Initiative

On April 25, 2006 the Global Compact Initiative was officially launched in Ukraine by UN officials in conjunction with many corporations and NGOs operating in Ukraine.

The Global Compact was set up in 1999 by the UN Secretary-General Kofi Annan as an attempt to gather global community to solve challenges of globalisation. Today it is an international network of companies, governments, UN agencies, NGOs and labour organizations working together to generate inclusive economic development. Business practice in these areas is governed by a set of 10 principles, which companies signing the Global Compact agree to adopt in their day-today operations. The social and political legitimacy of these principles is universally recognized, thus giving the Global Compact a leading edge.

The Chamber, to set a positive example for our Membership, has joined the UN Global Compact and committed to promoting the ten Global Compact Principles in the day to day operations:

Human Rights

- **1.** Businesses should support and respect the protection of internationally proclaimed human rights.
- **2**. Make sure that they are not complicit in human rights abuses.

Labor Standards

- **3.** Businesses should uphold the freedom of association and the effective recognition of the right to collective bargaining.
- **4.** The elimination of all forms of forced and compulsory labor.
- **5.** The effective abolition of child labor.
- **6.** The elimination of discrimination in respect of employment and occupation.

Environment

- **7.** Businesses should support a precautionary approach to environmental challenges.
- **8.** Undertake initiatives to promote greater environmental responsibility.
- **9.** Encourage the development and diffusion of environmentally friendly technologies.

Anti-Corruption

10. Businesses should work against all forms of corruption, including extortion and bribery.


CSR EVENTS




