Executive Summary

Key Findings:

1. The strategic partnership between the U.S. and Ukraine in defense technology is crucial for regional stability and global security.
2. Ukrainian defense innovations are reshaping modern warfare, offering novel and low-cost scalable solutions for NATO and democratic allies.
3. A targeted investment of \$10 billion in Ukraine's defense sector can significantly accelerate Ukraine's victory and benefit U.S. geopolitical interests.

Deepen NATO integration and cooperation with Ukraine to enhance collective security.

Enhanced Military Training, Joint Exercises, and Interoperability

- Bilateral and NATO-led exercises, specialized training programs, standardization of equipment and communications, and logistics and supply chain integration.

Advanced Defense Technology and Cybersecurity Cooperation

- Intelligence and surveillance sharing, cybersecurity assistance, and support for secure, NATO-compatible infrastructure, including air and missile defense.

Security Assistance, Defense Financing, and Strategic Infrastructure Investment

- Foreign Military Financing (FMF) for NATO-standard equipment, military aid pre-positioning, and investments in NATO-compatible infrastructure.

Policy and Diplomatic Pathways toward NATO Membership

From the inception of the Russian full-scale invasion, the U.S. has been a critical partner to Ukraine with multiple initiatives that have contributed to Ukraine's defense, including:

1. **Strategic Defense Framework Agreements:** In August 2021, the U.S. and Ukraine signed the Strategic Defense Framework to enhance defense cooperation, focusing on defense industry collaboration and cybersecurity. ([Wilson Center](#))
2. **Defense Industrial Base Conferences:** In December 2023, the U.S. Department of Commerce hosted the U.S.-Ukraine Defense Industrial Base Conference, bringing together over 300 representatives from U.S. and Ukrainian industries and governments to explore co-production and industrial cooperation opportunities. 3. **Foreign Military Financing (FMF):** In May 2024, the U.S. announced \$2 billion in FMF to help Ukraine develop its defense industry, including potential co-production with U.S. companies. ([Defense News](#))

1. Introduction

Purpose of the Report

This report synthesizes the insights from the **MITS Forum**¹ into actionable strategies and policy recommendations, highlighting the strategic importance of U.S. investments in Ukraine's defense sector. It also incorporates a broader geopolitical context to provide a comprehensive roadmap for enhancing Ukraine's defense capabilities and fostering U.S.-Ukraine cooperation.

Context and Background

Overview of the ongoing war in Ukraine and its global implications.

A New Era of Modern Warfare: The conflict has redefined contemporary military strategy, emphasizing asymmetric tactics, cyber warfare, and advanced technologies like drones and electronic warfare. Ukraine's innovative use of these tools to counter a larger force has shifted global military thinking, prompting NATO and other nations to reevaluate their defense approaches and prepare for a new era of tech-enabled, agile combat. This evolution is setting precedents for future conflicts, especially regarding rapid response, integrated defense systems, and resilience against cyber threats.

Economic Repercussions of Dependence on Russian Resources: The war has exposed the vulnerabilities in Europe's and Asia's reliance on Russian oil and gas, triggering an urgent drive to secure alternative energy sources. This shift has fueled investments in renewable energy and diversification of supply chains. The economic impact of these changes has been significant, contributing to rising energy prices, inflation, and the need for resilient supply chains to minimize geopolitical risks.

Democratic Resilience Against Authoritarian Hegemony: Ukraine's stand against Russian aggression has underscored a global ideological divide, with democracies uniting to defend against a growing authoritarian influence. This alignment has strengthened democratic resilience, reinforcing support for Ukraine as a symbol of sovereignty and freedom. It has also deepened alliances among democratic nations committed to countering authoritarian expansion, marking a new era of ideological unity and strategic collaboration among democracies in the face of emerging threats.

Ukraine's evolution into a hub of defense technology innovation: Ukraine has become a global center for defense technology innovation, advancing in UAVs, precision munitions, and electronic warfare to meet the demands of modern warfare. Driven by partnerships between the Ministry of Digital Transformation, Ministry of Strategic Industries and the Ministry of Defense, along with international support, Ukraine's tech

ecosystem has grown rapidly, with drone manufacturers expanding from about 20 to over 200 since the conflict's start. This evolution has positioned Ukraine as a critical, innovative partner for NATO.

Ukraine is an important Defense Industrial Base Partner for the U.S.: Ukraine's low-cost industrial base has enabled it to hold back the invader. It could be a major asset for the U.S. in closing the U.S.'s cost gap with China for the production of everything from drones to ordinance. In 2025, Ukraine will double its defense production and be able to start supplying the U.S. and democratic allies with some of the lowest-cost, battle-tested, China-component-free, and most effective weaponry in the free world.

The necessity of U.S.-Ukraine cooperation in addressing global security challenges: The U.S.-Ukraine defense partnership has become essential for addressing international security challenges, particularly as Ukraine serves as a frontline defense against authoritarian aggression. This collaboration leverages Ukraine's strategic geographic position and growing defense capabilities, making it a valuable partner in NATO's security framework and a critical force for regional stability. Through joint ventures and technology sharing, the U.S. can enhance Ukraine's resilience and diversify its own defense supply chains, reducing dependence on other global powers like China. This partnership strengthens collective defense mechanisms, fosters innovation in defense technology, and contributes to the democratic world's ability to counter emerging global threats.

2. Strategic Importance of U.S.-Ukraine Defense Tech Partnership

Enhancing Ukraine's Defense Capabilities

The critical role of U.S. investments in building Ukraine's local production and technological implementation.

U.S. investments are pivotal in accelerating Ukraine's path toward economic resilience and technological advancement, especially as it rebuilds amidst ongoing conflict. Early investments in local production and technology will support Ukraine's defense and economic foundation that aligns with Western standards.

U.S. investment in local production will fuel growth in critical sectors, including infrastructure, energy, Aerospace. Investors can straighten Ukraine's regional economies by focusing on immediate and localized rebuilding efforts, fostering a decentralized model that boosts efficiency and resilience. As highlighted by the Atlantic Council, initiating these efforts now rather than post-conflict will stabilize communities, preserve human capital, and lay the groundwork for long-term recovery. Furthermore, prioritizing renewable energy infrastructure will reduce Ukraine's reliance on traditional power sources, ensuring energy security and global sustainability goals.

Technology and innovation are integral to this transformation, with U.S. investments driving advancements in Ukraine's production capabilities. Ukraine's strengths in digital governance, exemplified by its Diia platform, show how public services can be streamlined, enhancing transparency and attracting investments. As the CSIS report emphasizes, supporting SMEs with impact investing will create jobs and foster a resilient, diversified economy. Modernizing sectors like agriculture and energy through technology will enhance productivity and position Ukraine as a critical player in regional and global supply chains.

For U.S. investors, Ukraine's rebuilding represents a dual opportunity: achieving financial returns while advancing democratic resilience on a global scale. By facilitating the growth of Ukraine's local production and technological capacity, U.S. investments will play a decisive role in strengthening Ukraine's economic independence and its integration with Western markets, creating lasting stability in Eastern Europe.

Fostering a robust startup ecosystem to drive innovation in defense technologies.

Ukraine's startup ecosystem has become a driver of innovation in defense technologies. Supported by government initiatives and private investment, Ukraine has accelerated advancements in drones, artificial intelligence (AI), and cyber defense—increasingly vital technologies on the battlefield.

Significant investments in defense-focused tech startups have turned Ukraine into a center for technological breakthroughs, delivering unique solutions tailored to the challenges faced by its defense forces. For example, the development of unmanned aerial vehicles (UAVs) for reconnaissance and strike capabilities has empowered Ukraine to confront larger adversaries with a level of sophistication and adaptability that is reshaping defense tactics.

Government support and international funding have been key to nurturing this growth. Through venture capital partnerships and accelerator programs, Ukraine has built a framework that encourages tech innovation and emphasizes scalable solutions compatible with NATO standards. This environment has attracted substantial foreign interest, enabling startups to expand their capacities and sustain critical R&D efforts even amid ongoing conflict.



In fostering this collaborative innovation ecosystem, Ukrainian defense tech companies work closely with the military, receiving direct field feedback to refine their products rapidly. By supporting these dynamic partnerships, U.S. and allied investments can further accelerate advanced defense tech development while bolstering Ukraine's economic resilience.

Ukraine's approach has created a model for rapid defense innovation, strengthening both its national security and the security of its allies. Continued investment in Ukraine's tech sector can secure this vital innovation pipeline, enhancing defense capabilities and global stability.

Case Studies and Success Stories

Digital Transformation in Defense: Ministry of Digital Transformation and Ministry of Defense initiatives on leveraging technology for military advantage:

- **Army of Drones:** This initiative has increased drone production and the development of ground-based robotic platforms, electronic warfare systems, and drone ammunition. Fedorov emphasizes that asymmetrical warfare involves deploying technologies to outmaneuver adversaries. [Source: Le Monde](#)
- **Brave1 Platform:** Launched in collaboration with defense agencies and the National Security and Defense Council, Brave1 serves as a defense tech cluster fostering scientific research and development. As of May 2024, over 1,600

developments and 1,000 producers have registered on the platform, accelerating the deployment of technological solutions to the front lines.

- **AI-Enhanced Drones:** In October 2024, Ukraine began deploying domestically developed AI-augmented systems for drones. These systems enhance target acquisition and enable autonomous flight in electronically contested environments, improving operational effectiveness.

- **Magura Drones:** The Magura V5 unmanned surface vehicle (USV) has demonstrated remarkable operational success, notably achieving the first recorded instance of a naval drone downing an airborne target. On December 31, 2024, a Magura V5 equipped with R-73 missiles successfully destroyed a Russian Mi-8 helicopter near Cape Tarkhankut in Crimea. Additionally, the Magura V5 has been instrumental in neutralizing Russian naval assets.

Human Resource Development: Maria Berlinska, a veteran and aerial reconnaissance specialist, leads the [Victory Drones](#) project under the [Dignitas charitable foundation](#). The project focuses on:

- **Drone Training and Production:** Victory Drones has launched initiatives like the "People's FPV" program, which educates Ukrainians on assembling kamikaze drones at home. This grassroots approach has empowered citizens to contribute directly to defense efforts. [Source: Ain](#)
- **Advocacy and Development:** Berlinska has been a vocal advocate for technological advancement in Ukraine's military, emphasizing the critical role of engineers and innovation in modern warfare. She has highlighted the necessity of developing interceptor drones to counter enemy UAVs effectively. [Source: Pravda](#)

In addition, an integral part of the international training ecosystem, [Boryviter Military School](#) provides free, intensive training to Ukrainian military personnel in areas such as fixed-wing and multi-rotor UAVs, FPV drones, military communications, land navigation, and command and staff training - enhancing the battlefield readiness of the Armed Forces of Ukraine. Further, Boryviter is actively involved in retraining wounded warriors and has been mandated to help Ukraine's military to institutionalize lessons learned processes.

The synergy between government initiatives and grassroots projects has led to:

- **Increased Drone Production:** The Ministry of Defense, in cooperation with the Ministry of Digital Transformation, has contracted 1.8 million drones for nearly 147 billion UAH [\$3.55 billion] for 2024-2025. [Source: Liga News](#)
- **Technological Advancements:** The development of AI-driven drones and platforms like Brave1 have established Ukraine as a leader in defense technology innovation.

Challenges and Resource Gaps

Critical Resource Shortages Hindering Ukraine's Defense Efforts

Ukraine faces resource shortages that limit its ability to sustain momentum on the battlefield. Insufficient artillery ammunition and long-range fires, combat air (to interdict Russia's ability to deliver glide bombs), layered air defense systems, and counter-drone technologies are significant obstacles, reducing Ukraine's ability to conduct decisive operations. Filling these critical gaps - along with replenishing operational stocks of conventional maneuver assets and spare parts/specialty tooling - is essential for bolstering Ukraine's defense and enabling sustained operations.

The Need for Advanced Technologies, Funding, and International Collaboration

The Cost of Insufficient Support

While the resources required to militarily defeat the Russian Federation Army on Ukrainian soil are substantial, they are far less than what the Western Alliance would need to mobilize if Ukraine were to fall, transforming into a key asset for an imperial Russia—let alone the effort required to deter other potential aggressors emboldened by a perceived lack of Western resolve.

This rapid scaling underscores Ukraine's resilience to sustain a self-reliant defense infrastructure.

5. Ukraine's Pivotal Role in NATO and Global Security

Strategic Importance to NATO

Ukraine as a Frontline Defender and Contributor to Global Security

Ukraine is a frontline defender against aggression, playing a key role in ensuring regional and global security through its domestic defense industry. The country's defense efforts, supported by military aid from the U.S. and its allies, are essential in countering Russian advances and upholding the security architecture in Europe. In addition, Ukraine's integration into NATO supply chains would further bolster the alliance's collective defense via increased manufacturing efficiency, creating a stronger deterrent against future aggression. Additionally, Ukraine's defense industry innovations are vital to the global security, providing NATO and its allies with advanced military solutions critical for maintaining international security in an evolving threat environment.

6. U.S. Investments in Ukrainian Defense Tech: Pathways and Potential

Navigating the Current Investment Landscape

Regulatory and Geopolitical Barriers

U.S. investments in Ukraine's defense sector face regulatory and geopolitical obstacles, primarily due to export controls like the International Traffic in Arms Regulations (ITAR) and complexities associated with investing in an active conflict zone. These restrictions limit the influx of U.S. capital, confining most investments to early-stage funds willing to navigate the challenges of Ukraine's defense industry. Furthermore, strict export controls and concerns over repatriation discourage larger, long-term investments, as the elevated risk profile demands cautious entry. These constraints underscore the need for policy adjustments to incentivize broader external capital participation and support the resilience of Ukraine's defense industry.

Unlocking Strategic Value in Ukraine's Undervalued Defense Assets

Ukraine's defense sector offers a compelling investment opportunity, with assets historically undervalued on the global stage. A notable example is Motor Sich, a premier Ukrainian manufacturer of aircraft engines used worldwide, which was the subject of a Chinese acquisition attempt for under \$1 billion in 2021. This valuation starkly contrasts with the strategic importance of such assets.

Allocating \$10 billion to Ukraine's defense industry could catalyze a modernization of critical facilities, including Motor Sich. This investment would not only enhance production capabilities but also ensure that pivotal defense technologies remain under allied control, thereby preventing adversarial access. The infusion of capital aligns with both U.S. and NATO strategic interests.

A \$10 billion investment would secure critical technologies and bolster global security. In comparison, the U.S. Department of Defense's budget for fiscal year 2024 is approximately \$842 billion. Allocating \$10 billion to Ukraine's defense sector represents about 1.2% of this budget, a relatively modest expenditure considering the substantial strategic benefits. This investment would not only strengthen Ukraine's defense capabilities but also contribute to regional stability and the broader security objectives of the U.S. and its allies.

Potential Global Impact

Diversifying Global Defense Supply Chains and Reducing Reliance on Non-Allied Nations

In an era of constrained global supply chains and increasing dependence on China, Ukraine's defense sector and vast mineral reserves offer an opportunity for diversification. By integrating Ukraine's defense manufacturing capabilities into NATO's supply chains, the U.S. and its allies can reduce reliance on non-allied nations for critical materials and technology. Furthermore, Ukraine's innovations in areas like unmanned systems and cybersecurity contribute to its defense and global commitment to democracy and freedom, securing Ukraine's position as a pivotal partner in the future of defense strategy.

A key example of Ukraine is the city of Dnipro, often called Ukraine's "space city". It has been a cornerstone of the nation's aerospace industry since the Soviet era. The city is home to major enterprises like Yuzhmash (Pivdenmash) and Yuzhnoye (Pivdenne), which have been instrumental in manufacturing launch vehicles and spacecraft components. Notably, Yuzhmash produces the first stages of Northrop Grumman's Antares rocket, which was used to launch the Cygnus cargo vehicle to the International Space Station, and engines for Europe's Vega rockets. This strategic importance has been recognized globally, with Dnipro's contributions integral to international space missions.

Faced with urgent defense needs, academia, industry, and the government in Ukraine are collaborating more closely than ever. This unprecedented alignment is fostering a developing startup ecosystem producing breakthroughs that meet immediate operational requirements and drive the future of defense innovation. Academia is focusing its research on high-impact areas like cybersecurity, artificial intelligence, and unmanned systems, addressing the needs of the defense sector. Industry partners are collaborating to bring these innovations to market, fast-tracking product development to meet real-time demands on the battlefield. Through targeted policies, grants, and infrastructure investment, government support further strengthens this ecosystem, providing the resources and incentives needed to scale new technologies.

A Model for Defense Tech Success

This unified effort in Ukraine is setting a new standard for defense innovation, with the potential to achieve success as a defense technology powerhouse. By aligning goals across sectors, Ukraine's startup ecosystem is uniquely positioned to produce innovations at a pace and scale that is difficult to achieve elsewhere. Government incentives ensure that research evolves into practical applications, while collaboration with industry enables rapid deployment and scaling of these innovations. The collective focus on a shared mission creates an environment ripe for breakthroughs that enhance Ukraine's defense capabilities and offer strategic benefits to NATO and U.S. partners. By fostering this unprecedented cooperation, Ukraine's defense tech ecosystem could emerge as a leader, delivering advanced solutions that fortify security internationally.

8. Recommendations and Strategic Proposals

Policy Measures

Beyond directly infusing capital into the Ukrainian Defense firms, the overall ecosystem could be bolstered through:

- **Tax Incentives for U.S. Companies:** Introducing tax credits or deferrals for U.S. defense firms investing in Ukrainian operations could reduce financial risk and encourage for American companies to partner with Ukraine's defense industry.
- **Creation of Bilateral Investment Funds:** Establishing a dedicated U.S.-Ukraine defense investment fund (fund of funds) with contributions from both governments could provide early-stage funding and venture capital for joint defense projects, similar to the Israel-U.S. Binational Industrial Research and Development (BIRD) Foundation model.
- **Streamlined Export Licensing for Dual-Use Technologies:** Easing export control regulations on specific dual-use or defense technologies could simplify the process for U.S. companies to share necessary technologies with Ukrainian partners while ensuring security compliance.
- **Facilitating Joint R&D Initiatives:** Launching grant programs for joint R&D projects between U.S. and Ukrainian defense companies or academic institutions could support advancements, particularly in cybersecurity, drone technology, and advanced materials.
- **Developing Insurance Programs for Conflict Zones:** Partnering with institutions like the World Bank or private insurers to create insurance products specifically for investments in active conflict zones like Ukraine would mitigate risk for U.S. investors and companies operating in Ukraine.
- **Public-Private Partnership Programs (PPPs):** Expanding U.S. government-backed PPPs in Ukraine's defense sector could mobilize private capital for projects with high initial costs, such as manufacturing facilities or technology development.
- **Incentivizing Ukraine's Adoption of NATO Standards:** Supporting Ukraine in adopting NATO interoperability standards for its defense products would make it easier for U.S. defense companies to collaborate and invest, as products would align with broader alliance requirements.
- **Enhancing Regulatory Support for Private Debt Financing:** To bolster Ukraine's defense sector, it's crucial to enhance regulatory support for private debt financing. One effective approach is to expand the mandate of the U.S. International Development Finance Corporation (DFC) to include defense-related projects. This expansion would enable private U.S. lending institutions to extend credit lines to Ukrainian defense firms, with the DFC providing partial guarantees to mitigate risks.

Strengthen Ukraine's manufacturing capabilities to create a sustainable defense industrial base.

- **Direct Investment and Financial Support**

- **Foreign Military Financing (FMF) Grants and Loans:** Increasing FMF grants and low-interest loans for Ukraine's defense sector would provide critical funds for building new facilities, upgrading plants, and maintaining operational capital, fostering sustainable production growth.
- **Loan Guarantees for American Companies:** Issuing U.S.-backed loan guarantees for American companies investing in Ukraine's defense manufacturing could encourage private sector engagement by reducing investment risks, especially in active conflict zones. The U.S. International Development Finance Corporation (DFC) has already implemented such measures, providing a \$40 million loan portfolio guarantee to Raiffeisen Bank Ukraine to support lending to small and medium-sized enterprises. Extending similar guarantees to American investors in the defense industry would further stimulate investment in Ukraine's defense sector.
- **Defense Production Act (DPA) Funding for Critical Projects:** Through the DPA, the U.S. could allocate funds specifically to support Ukrainian production in high-priority sectors, such as drones, precision munitions, and cyber-defense technologies, helping Ukraine scale its capabilities.

- **Technical Assistance and Training Programs**

- **Technology Transfer Programs:** Facilitating technology transfer for essential defense components, like unmanned systems or encrypted communication equipment, would help Ukrainian manufacturers produce critical components locally, reducing dependence on imports.
- **Engineering and Manufacturing Expertise Development:** Deploying U.S. advisors and establishing training programs could upskill Ukrainian workers in precision manufacturing, quality control, and electronics, equipping Ukraine with production capabilities.

- **Facilitating Access to U.S. Defense Markets**

- **Easing Pathways for Ukrainian Products:** Simplifying procurement pathways for Ukrainian defense products that meet U.S. standards could increase Ukraine's market access, providing a revenue stream that supports further development and growth in Ukraine's defense industry.
- **Integrating Ukrainian Suppliers into the U.S. Supply Chain:** Programs that incorporate qualified Ukrainian manufacturers into the supply chains of U.S. defense companies would help strengthen the U.S. supply base while providing Ukraine with sustainable business opportunities.

Policy and Diplomatic Support for NATO Membership Pathways

- **Defining a Membership Action Plan (MAP):** The U.S. could advocate within NATO for a structured Membership Action Plan for Ukraine, setting milestones for

integration. By outlining a clear path to membership, the U.S. would reinforce Ukraine's position and commitment to the alliance's collective security.

- **Engaging Allies for Support:** Through diplomatic channels, the U.S. can work to secure backing from NATO allies for Ukraine's membership aspirations, particularly from countries with reservations. Increased advocacy for Ukraine's NATO integration would promote unity and incentivize reforms.

Strategic Infrastructure and Defense Readiness

- **Investment in NATO-Compatible Infrastructure:** Funding and advising Ukraine on the construction of NATO-standard military infrastructure, including command centers, airfields, and logistics hubs, would allow Ukraine to serve as a forward-operating base for NATO, enhancing regional readiness.
- **Integrated Air and Missile Defense:** Working with NATO allies, the U.S. could help integrate Ukraine into NATO's air and missile defense network, establishing interoperable early-warning systems, radars, and interceptors to protect Ukraine and allied territories from aerial threats.

Inclusion in NATO's Response and Defense Mechanisms

- **Participation in NATO Exercises and Missions:** Encouraging Ukraine's active participation in NATO's Response Force exercises and humanitarian missions would help familiarize Ukrainian forces with NATO's rapid deployment and operational protocols.
- **Incorporating Ukraine into NATO Cyber and Intelligence Networks:** The U.S. can facilitate Ukraine's involvement in NATO's intelligence-sharing platforms and cyber defense mechanisms, enhancing cooperation on regional security threats and building collective response capabilities.
- **Integrate Ukraine into NATO's Forward Defense:** With the recent addition of Finland and Sweden and potential accession of Ukraine into the Western Alliance, NATO has the potential to create for the first time in its history a contiguous and integrated Eastern front. As a NATO member, Ukraine could be tasked with denying freedom of movement of Russia's Black Sea fleet, acting as a protective glacis for Moldova, Romania and Bulgaria, blocking Russian aggression against Poland, and hosting NATO air bases to surveil and - if necessary - interdict Belarusian and Russian forces.
